



## Grades 1 to 12 transportation

### CTSE's Main Regulations Summary

#### CTSE002 – TRANSPORTATION ELIGIBILITY

Walking distances between the school and the residence or address on file:

- Grades 1 to 3 → 0.8 km
- Grades 4 to 6 → 1.0 km
- Grades 7 to 12 → 2.0 km

Walking distance between the bus stop and the residence or address on file:

- Grades 1 to 12 → 500 m

#### CTSE004 – STUDENT RESPONSIBILITIES

The student must respect the school's code of conduct which applies at all times aboard the school vehicle.

The student must be at the designated stop ten (10) minutes before the school vehicle's scheduled arrival time.

The student must follow the driver's instructions and respect Bus Patrol Representatives.

#### CTSE012 – ESTABLISHMENT OF SCHOOL VEHICLE ROUTES

For students from Junior Kindergarten to Grade 6, the route can last up to 60 minutes.

For students from Grades 7 to 12, the route can last a maximum of up to 90 minutes.

#### CTSE014 – LOCATION OF STOPS

All students without exception must walk to a corner stop or a common stop in order to take their school vehicle. Home stops are only authorized when the speed limit exceeds 50 km/h.



#### CTSE015 – COURTESY TRANSPORTATION

Effective October 1st, courtesy transportation may be granted to students who are within the walking distance to school. Certain conditions apply. The form is available as of September 15th only.

#### CTSE016 – JOINT CUSTODY

Transportation to two addresses **may** be assigned in case of joint custody. Both addresses must be in the school zone and a regular schedule must be provided to the CTSE.

The Joint Custody form signed by both parents must be submitted to the CTSE before the request can be evaluated.

## JK and SK transportation

#### CTSE002 – TRANSPORTATION ELIGIBILITY

Junior and Senior Kindergarteners can walk up to 250m to their designated stop.

Students residing within 250m of the school are not eligible for school transportation.

#### CTSE004 – STUDENT RESPONSIBILITIES

The student must respect the school's code of conduct which applies at all times aboard the school vehicle.

The student must be at the designated stop ten (10) minutes before the school vehicle's scheduled arrival time.

The student must follow the driver's instructions and respect Bus Patrol Representatives.

#### CTSE012 – ESTABLISHMENT OF SCHOOL VEHICLE ROUTES

The route can last up to 60 minutes.

#### CTSE013 – JK AND SK DROP-OFF

In accordance with the Green Tag Program, all Kindergarteners must be met by a designated responsible adult at their drop-off location.

#### CTSE014 – LOCATION OF STOPS

All students without exception must walk to a corner stop or a common stop in order to take their school vehicle. Home stops are only authorized when the speed limit exceeds 50 km/h.



#### CTSE016 – JOINT CUSTODY

Transportation to two addresses **may** be assigned in case of joint custody. Both addresses must be in the school zone and a regular schedule must be provided to the CTSE.

The Joint Custody form signed by both parents must be submitted to the CTSE before the request can be evaluated.
